

**C-PEC Revision of fee Structure after implementation of GST w. e. f. 01 July, 2017**

As you are aware that Centre for Professional Excellence in Cooperatives (C-PEC), has been set-up within Bankers Institute of Rural Development (BIRD) to streamline training systems in cooperative Credit Structure (CCS) to ensure availability of professional staff with the cooperatives for efficient delivery of banking and financial services.

**02.** As of now C-PEC is collecting a token amount from individuals and institutions towards life time membership of C-PEC to create sense of ownership among CCS stakeholders. In addition to the membership fee, C-PEC is also collecting accreditation fee from the member institutions which are applying for accreditation/reaccreditation with C-PEC.

**03.** With the rollout of Goods & Service Tax (GST) w.e.f. 01 July 2017, the membership and accreditation fees attract GST@18%. Thus, the revised membership & accreditation fees structure of C-PEC is as follows:-
